

## **ADMISSION DECISIONS**

## STUDY PROGRAM LAW AND MANAGEMENT OF REAL ESTATE AND INFRASTRUCTURE (BA) ACADEMIC YEAR 2016/2017

The Admission Affairs Committee composed of three members, following the review of applications for admission to validated bachelor study program Law and Management of Real Estate and Infrastructure (BA) of Nova Univerza in the academic year 2016-2017, and following the review of the fulfillment of criteria of students for admission according to the following weight:

- Secondary school education with the Grade Point Average of at least 3.5;
- Successfully passed matura examination (minimum 100 points out of 200 points);

In the event of limited enrollment the Admission Affairs Committee gave the following weight to the criteria:

- GPA − 70 %;
- Matura Exam results 30 %;

The minimum points for full admission to the study program is sixty. In the event the candidate achieves less than 60 points in the range from 56 to 59, he/she is provided with the conditional enrollment status, which is converted to full admission status if until the end of enrollments there are no other students with full admission status. The students with conditional enrollment status must be subject to entry exam and interview in which 50 points must be achieved at least out of 100 in exam and 70 points out of 100 in interview.

The results of admission applications for applicants to admission to study program Law and Management of Real Estate and Infrastructure (BA) and status of their enrollment in the academic year 2016/2017 is presented below:
