

## **ADMISSION DECISIONS**

## STUDY PROGRAM MANAGEMENT OF REAL ESTATE AND INFRASTRUCTURE (MA) ACADEMIC YEAR 2017/2018

The Admission Affairs Committee composed of three members, following the review of applications for admission to master study program Management of Real Estate and Infrastructure (MA) in the academic year 2017-2018, and following the review of the fulfillment of criteria of students for admission according to the following weight:

- Grade Point Average of at least 7.5;
- Relevant Working experience;

In the event of limited enrollment the Admission Affairs Committee gave the following weight to the criteria:

- GPA 75 %;
- Relevant experience 25 %;

In the event the applicant has an extensive experience of more than three years in the field of construction management and real estate management, the criteria of GPA shall be revoked.

The minimum points for full admission to the study program is seventy. In the event the candidate achieves less than 70 points in the range from 66 to 69, he/she is provided with the conditional enrollment status, which is converted to full admission status if until the end of enrollments there are no other students with full admission status. The students with conditional enrollment status must be subject to entry exam and interview in which 50 points must be achieved at least out of 100 in exam and 70 points out of 100 in interview. For every year of relevant experience that exceed the minimum of three years of working experience in construction, real estate sector, and urbanism, 0.5 points are added.
