

# Review of the study program Law and Management of Real Estate and Infrastructure (BA) from alumni perspective

College ESLG conducted a program evaluation and distributed the program evaluation form to all bachelor students' graduates through Google Forms. From 127 graduates to whom the questionnaire was distributed only 26 responded. The same evaluation form is also available in the Electronic Grading System but it is not mandatory. The College ESLG will make the program evaluation form mandatory to all graduates before and they must fill it immediately upon the login in Electronic Grading System

The survey is composed of five sections. Sections of the survey are as follows:

- 1. PREPARATION AND SUCCESS IN LABOR MARKET composed of nine questions with Likert Scale from 1 to 5 (very dissatisfied to very satisfied);
- 2. ACQUIRED KNOWLEDGE AND SKILLS composed of eleven questions with Likert Scale from 1 to 5 (very dissatisfied to very satisfied);
- 3. Written comments with three text boxes composed of which part of the program prepared you best for the career advancement, which part of the program prepared you the least for the labor market and what would you improve in the quality of the program to best cope with the career and labor market challenges in Kosovo and internationally;

The present study of alumni evaluation of the program shall focus on each section separately and draw recommendations for each of them, which will be further incorporated in the end in the strategic plan document of the study program. We run both descriptive statistics and multiple regression to generalize about the effect of each of independent variables on the dependent variable.



## PREPARATION FOR AND SUCCESS IN THE LABOR MARKET

For each section the descriptive statistics was run in order to superficially find out which of the aspects of preparation and success in the labor market influenced mostly the alumni satisfaction (those students that were subject to program evaluation). The descriptive statistics analysis was run in SPSS. The variables included in the bachelor program alumni survey are not the same as the ones performed for master studies. The bachelor version has less variables related to preparation and success in the labor market. The statistical analysis has been presented in Table 1.

From 129 respondents (existing graduates of the bachelor program) who were sent an invitation to fill program evaluation forms only 27 responded effectively. Questions of the questionnaire were with Likert Scale 1(very dissatisfied), 2 (dissatisfied), 3(somewhat satisfied), 4 (satisfied) and 5 (very satisfied). From the responses, the present report finds out that all respondents are highly satisfied with the level that the program prepares them for labor market and the success they achieve in the labor market by each of the variables having the mean higher than 4.0 as described in Table 1. From all variables preparation for labor market has the highest mean of 4.35 and standard deviation of 0.689 and 0.475 followed by career advancement with the same mean of 4.35 but wider standard deviation of 0.745 and variance of 0.555. Next progress in entrepreneurship as a consequence of study program has achieved the mean of 4.23 followed by transition in the labor market with the mean of 4.19 and level of preparation and success in the labor market. The



lowest mean is achieved by employment progress with only 4.0 and standard deviation of 0.894 and variance of 0.800.

Next we run multiple regression to see which of the independent variables has the highest effect on the level of preparation and success in the labor market.

From independent variables only employment progress has the highest positive effect on the level of preparation and success in the labor market with b=0.659 and t=3.499 meeting the Nunnally (1969) requirement, which is b>0.1 and t>1.96.

# ACQUIRED KNOWLEDGE AND SKILLS

The descriptive statistics for the alumni satisfaction with the acquired knowledge and skills has been presented in Table 3.

From the descriptive statistics, students have high satisfaction with all the skills that they think they gained due to the study program, whereby all of them achieved the mean higher than 4.0. Program helped you to work effectively as a team member is the skill that reached the highest mean of satisfaction of students with 4.62 and standard deviation of 0.571, whereas Program helped you to be an innovator has the lowest mean of 4.12 and standard deviation of 0.816.

Next, we run a multiple regression analysis to see which independent variables have the highest effect on the dependent variable, which is General satisfaction with the level of knowledge and skills that you acquired during the bachelor program. Multiple regression analysis has been presented in Table 4.

From the multiple regression analysis Program helped you to work effectively as a team member has b= .366 and t=1.767 having the highest effect on the level of knowledge and skills acquired during the bachelor program, followed by Program helped you to acquire skills on your own with b=0.374 and t=1.432. The same moderate effect is exercised also by the variables Program helped you to be an innovator with b=0.233 and t=1.373 and Program helped you to communicate well orally with b= 0.252 and t=1.369 and Program helped you to have awareness for environment with b=0.233 and t=1.365.

The variables with the very low effect are program helped you to identify moral and ethical issues, program helped you to function independently, program helped you to think analytically, program helped you to be an effective leader, and program helped you to write effectively and clearly.

## QUALITATIVE ANALYSIS BASED ON WRITTEN COMMENTS

The table of respondents with the written comments on best part of the program, the part of the program which least contributed to their success in the labor market and how would they improve the overall quality of the program to increase the success in the labor market has been presented in Table 5.

From the qualitative analysis some of the issues are recurring in most of the responses of the students such as real estate appraisal, problem-based learning, lectures with case studies, research and essay assignments as best parts of the program.

The respondents think that adding more exercises, more research in each of the courses and more field visits are the components that should be strengthened further so students can have more success in the labor market.



## EVALUATION BY PROGRAM DIRECTOR AND RECOMMENDATIONS

The program director Assoc. Prof. Dr. Visar Hoxha after thorough examination of the findings from the alumnae program evaluation, reaches the following conclusions:

# PREPARATION FOR AND SUCCESS IN THE LABOR MARKET

Students have the satisfaction with the mean of greater than 4.0 with regards to preparation for and success in the labor market in all the fields, however they have the lowest satisfaction on employment progress with the mean of 4.0. Also from multiple regression analysis the employment progress has the highest effect on the overall satisfaction of students with the level of preparation and success in the labor market.

#### Recommendation:

- Increase the memoranda of understanding with construction sector for paid practical internship of students so students can have better employment opportunities;
- Organize recruitment fair for the construction sector companies, where they can recruit for real estate managers;
- Better career counselling support and advise for students who are about to graduate.

# ACQUIRED KNOWLEDGE AND SKILLS

Students have the satisfaction with the mean of greater than 4.0 with regards to acquired knowledge and skills in all the fields, however they have the lowest satisfaction with the Program helped you to be an innovator, which has the lowest mean of 4.12 and standard deviation of 0.816. On the other hand, from multiple regression we conclude that the variables with the very low effect on the level of satisfaction of alumni on the preparation and success in the labor market (which has a generally high mean greater than 4.0) are program helped you to identify moral and ethical issues, program helped you to function independently, program helped you to think analytically, program helped you to be an effective leader, and program helped you to write effectively and clearly.

#### Recommendation:

- Add more innovative project assignments in the classes;

- Include the Best Innovator Award in the field of construction and real estate management, with the scholarship awarded for the winner;
- Add ethical dilemma problems as case study problems nearly in each course to strengthen the identification of moral and ethical issues;

# QUALITATIVE ANALYSIS BASED ON WRITTEN COMMENTS

From the qualitative analysis the recurring issues arise in most of the responses of respondents as best feature of the program that helped them most in the career and success in labor market:

- Real estate appraisal;
- Problem-based learning with case studies;

From the qualitative analysis the recurring issues arise as the most relevant among alumni responses as what needs improvement in the program to help them better in coping with challenges of labor market locally and internationally are:

- More exercises:
- Increase site visits;
- Better coordination of practical obligation;

## RECOMMENDATION

- Increase the number of exercises with mentors and tutors
- Implement these memoranda of cooperation with more site visits and practical work of alumni with private sector companies;
